Competition Terms and Conditions

Date last revised: October 2023

These terms apply to the School Quidditch Competition ("Competition") where you can win a Enrich Education Quidditch Equipment bundle, containing a set of 6 Hoops, 5 Quaffle balls, 15 Bludger balls and 5 Golden snitch belts and a Active Reading for Pleasure Through Quidditch Resource Liabary as well as a Quidditch eventday experience and staff training session. The event day and training must be booked and delivered between 31/10/2023 – 30/04/2024 ("Prize"). The Competition is run by Enrich Education, C/O Westvale Primary school, Melverley Road, Kirkby, L32 ORQ ("we/us/our").

Entry

To enter the Competition, you must: complete an official registration form across one of our marketing channels and fulfil all entry requirements. Entries that are incomplete or incorrect cannot be accepted, and we may not notify you in these circumstances.

The Competition runs from 07:00 on 12/10/2023 until 23:00 on 31/10/2023 (inclusive). All entries received after the closing date and time will not count.

You must ensure that you fill out your own entry and your entry is your own work and does not infringe a third party's rights.

Eligibility

To enter, you must be a UK resident, aged 18 or over and be an active member of the teaching staff at a school within the UK. In entering the Competition, you confirm that you are eligible to do so. Proof of eligibility may be required.

Only one entry can be submitted per person and you can only enter for yourself; not on behalf of or with anyone else, only one entry per organisation/school will be counted. There is no limit to the number of entrants that may participate.

Prize

Where the Prize is one of our products or services, use of that Prize is additionally subject to our terms and conditions applicable to the use of the relevant product or service. Where the Prize is attendance at one of our workshops, your attendance is always subject to availability and our booking terms and conditions, available on our website at HERE

Where the Prize is a third party product, we do not automatically transfer any manufacturer's warranty for the product to you. If there are any problems with the relevant Prize (e.g. where it is faulty) you must notify us within 12 months. We do not offer any repair or replacement warranty with your Prize in those circumstances; but your statutory rights (if any) are not affected.

To claim the Prize, you must respond the official communications from Enrich Education, this communication will come in the form of emails, and phone calls to the contact information provided. Provided you are eligible to enter the Competition, you can claim the Prize by 30/11/2023. You are able to refuse the Prize if you wish; no alternative Prize is available and we reserve the right to give the Prize to someone else if: a) you are not eligible to win the Prize or enter the Competition; b) you don't want the Prize; or c) we cannot contact you after making reasonable attempts to do so.

The Prize is non-negotiable and non-transferable. Our decision is final.

We can't take any responsibility if you cannot or do not accept the Prize. Entering this Competition does not guarantee that you will win the Prize. Winners are selected at random by athrid party selection software and process is recorded and posted across social media channels.

Liability

Insofar as permitted by law, and unless caused by our negligence, we will not (in any circumstances) be responsible or liable to compensate you, or accept any liability for loss, damage, personal injury or death occurring as a result of taking up or using the Prize.

Nothing in these terms affects your statutory rights (if any).

Ownership

We (or our licensors) own all competition entries and accompanying material submitted to us will become our property on receipt and will not be returned to you.

We reserve the right to publish details about this Competition online, through our social media channels or via other electronic or hard copy communications and publications, from time to time. By entering the Competition, you give us the right to use your name for these purposes, without payment.

Data protection

We process your personal data in connection with entering the Competition, and you need to provide us with your Full name, Email Address, School Name, School Post Code, Phone Number, Job Title. All personal data is processed by us as data controller in accordance with our privacy policy available <u>HERE</u>

General

If we consider there has been a breach of these terms at any time, we may exclude you from the Competition.

We may void, suspend, cancel, or amend the Prize or the Competition at any time, where necessary.

These Competition terms are governed by English law. If you wish to take court proceedings, they must be within the English courts.
